## Founder's Desk

I, C. Govindakrishnan, fondly known as Gopi, am extremely happy to share my joy with one and all that I completed 30 years of service to the Differently Abled community on October 02nd, 2022. It has been a great privilege for me to establish Nethrodaya as an institution to serve the Visually Challenged community of Tamil Nadu.

As I recall the journey traversed so far in the service of the Differently Abled, especially the Visually Challenged community, I fondly recollect the initial five years I spent as part of the Association of Blind Students. We were spearheading a movement for securing the basic rights of the Visually Challenged student community by participating in protests, hunger strikes and rallies. We represented the legitimate demands of the Visually Challenged community with various Government Departments. As I was at the forefront of many agitations for establishing the education and employment rights of the Visually Challenged, I was imprisoned more than fifteen times. The Government Departments finally agreed to our demands and provided employment opportunities and other facilities for the welfare of the Visually Challenged student community.



Thereafter, I joined Banyan, as a Project Officer where I got an opportunity to serve the mentally ill, destitute women. During this period, I was involved in rescuing destitute women from streets who belonged to various States of India and hospitalizing them as they were suffering from Physical and Mental Ailments. After their rehabilitation, it is indeed a great pleasure that I have been instrumental in restoring 122 of the rescued women and reuniting them with their respective families.

Nethrodaya was born on 02nd October 2002 in a rented building that measured 450 square feet with a Seed Capital of Rs. 82/-. In 20 years of our existence, we have grown gradually and Nethrodaya is now housed in its own building with an approximate area of more than 20,000 square feet built on a plot of land allotted to Nethrodaya by the Government of Tamil Nadu. It gives me immense happiness and fulfilment when I see many of my dream initiatives for the welfare of the Visually Challenged community turn into reality in the past 20 years. All these strategic welfare initiatives were possible due to the unconditional support of donors, volunteers, well-wishers, kind-hearted individuals and members of the society who have stood by me.

Nethrodaya has been able to serve thousands of Visually Challenged persons during the past 20 years by offering quality education at the school and college level, creating opportunities for employment and delivering Medical Services for the Visually Challenged individuals. All the above services are provided completely free of cost. I appeal to all supporters of Nethrodaya to stand by us in the future initiatives which will transform the lives of the underprivileged Visually Challenged individuals to live a life of dignity and fulfilment.



The message that could be taken from my life is that with the right amount of perseverance, thought and action, no problem, no matter how large it seems, could never be a hindrance to one who wants to serve himself and also others.

## Milestones

### 2002 - Establishment of a Free Hostel for Visually Challenged college students



Visually challenged boys & girls approach city colleges to pursue their higher education. After admission, they are denied boarding & lodging facilities due to their poverty. Nethrodaya identified this pressing need and

established a free residential facility for underprivileged visually challenged students who hail from remote villages of Tamil Nadu. More than 1,500 students have benefitted from this initiative.

### 2003 - Establishment of an Exclusive Computer Training Centre



The visually challenged have been deprived of part-time computer training programs for many decades. Nethrodaya identified this much-felt need and understood the potential this skill had in widening the range of opportunities for the visually challenged. Nethrodaya's Computer Training Centre, exclusively catering to the visually challenged students has been a boon to them and has benefitted more than 1,000 students so far. Students also use the centre for browsing services after college hours.

### Launch of an Exclusive Medical Help Line for the Visually Challenged



To provide 24X7 quality medical services for the underprivileged visually challenged, Nethrodaya launched a cost-free helpline 044-26533680. The helpline has received more than 2,000 calls and provided medical care to more than 1,000 Visually Challenged.

### Creation of Audio Study Material for the Visually Challenged



The visually challenged relied on Braille textbooks for many decades. They undergo tremendous stress due to the non-availability of Braille textbooks in schools and colleges. A path-breaking initiative was taken by Nethrodaya to address the immediate need by launching

Audio Study Material for the underprivileged visually challenged children who pursue their education in various districts of Tamil Nadu. 8,000 Audio Books have been distributed so far, free of cost.

### Self-Employment Scheme

This scheme provides seed capital to families of unemployed visually challenged persons, whose day-to-day survival proves to be a huge challenge. Nethrodaya procures and distributes marketable products to visually challenged persons who then sell them in trains and earn a living on a daily basis. The beneficiaries feel motivated and independent, and strive to do better every day.



### Supporting the Children of Visually Challenged Parents

Nethrodaya devised a scheme to fund the education of the children of Visually Challenged parents. These sighted children of visually challenged parents not only get to complete their education unhindered but also grow to be sensitive caretakers of their parents.

### Allotment of Land – GO No. 748

The Government of Tamil Nadu issued a Historic GO No. 748 dated 20.11.2006 for allotment of land to Nethrodaya towards establishing State of the Art Resource Centre for educating economically backward differently abled students from remote villages of Tamil Nadu.



### Cow Project

Launched in 2006, the scheme provides families of visually challenged persons with a Cow and a Calf. The livestock given free of cost helps economically backward families to get a stable income and lead their life with self-esteem.







## 2009 - Inauguration of State of Art Infrastructure facility for Differently Aabled



Foundation stone was laid in 2008 and state of art barrier-free building was inaugurated in 2009 towards educating Differently Aabled, underprivileged students of Tamil Nadu.

## 2012 - Establishment of Free Residential Higher Secondary Special School



A Government recognised Free Residential Special School for the Visually Challenged and Physically Challenged for both boys & girls was inaugurated in 2012.

## 2015 - Nethrodaya College of Special Education



Nethrodaya College of Special Education was inaugurated in the year 2015. It is recognized by the Rehabilitation Council of India and affiliated to Tamil Nadu Teachers Education University. It provides free admission to visually challenged

and orthopedically disabled boys and girls from poor families, completely free-of-cost

## 2018 - Death with Dignity

The scheme was launched in 2018, in all 38 districts of

Tamil Nadu. Nethrodaya believes that the death of visually challenged persons must be treated with dignity, assuring a decent cremation/burial. Due to lack of family support and poverty most of them are unable to perform the last rites for their loved ones who are visually challenged. With this initiative, they will now be able to perform the final rites and funeral of their loved ones, giving them a dignified final farewell.



## 2022

### Establishment of an Exclusive Fitness Centre

The first-of-its-kind exclusive Fitness Centre for the differently abled was inaugurated in the year 2022, setting new norms in encouraging independence and accessibility for the differently abled community in Tamil Nadu.



### Monthly Free Grocery Scheme

Nethrodaya provides free monthly groceries to families of visually challenged persons who are unable to make ends meet due to poverty. 200 families have benefitted from this scheme so far.





## Advocacy

Nethrodaya strongly believes that vibrant advocacy is the need of the hour to bring about real changes in the lives of differently abled persons. Standing its ground and consistently fighting for them, Nethrodaya obtained favourable orders from the Madras High Court and Government of Tamil Nadu benefitting the visually challenged community at large.

Nethrodaya fought a legal battle in the High Court of Madras against the Resident Welfare Association who had challenged the Government's allotment of Land to Nethrodaya on the grounds of Social Untouchability. After carefully examining the petition, The Chief Justice of Madras High Court passed a landmark judgement on 17th October 2008 condemning the association's objection and also imposed a fine on the petitioner.



Disability and poverty together restrain many visually challenged individuals from completing their education. Nethrodaya approached the Department of School Education and obtained a GO to exempt fee for visually challenged private candidates appearing for board exams conducted by the Directorate of School Examinations (GO No. 220 dated 09.07.2013). Furthermore, to make it convenient for the community, Nethrodaya was also instrumental in obtaining a GO from the Department of School Education to permit visually challenged students to apply online for their board exams (GO NO. 220 dated 09.07.2013).

Nethrodaya understood that non-availability of scribes was a major impediment in visually challenged persons' education and hence approached the Madras High Court requesting to direct the Government of Tamil Nadu to frame new guidelines and issue Government Orders for the appointment of scribes who can appear with visually challenged students at their board/university exams. The historic judgement that came on 28th January 2016 directed the Government of Tamil Nadu to issue modified guidelines by incorporating suggestions from Nethrodaya. Our rigorous follow up also ensured that the orders were issued by the Department of School Education and Higher Education, and implemented soon after.





Nethrodaya's advocacy efforts were channelled by its founder's long term vision and determination to set up a favourable ecosystem in the society that allowed support services for the visually challenged persons to prosper. This vision led the institution to a new milestone – obtaining a judgement from Madras High Court that exempts building approval fee from the Department of Housing and Urban Development. The GO has not only benefitted Nethrodaya but has also favoured many other welfare institutions run for the differently abled (GO No. 31 dated 09.03.2018).

The Department of Welfare of Differently Abled Persons provides a maintenance allowance of Rs. 2,000/- to each severely disabled person affected with mental retardation, muscular dystrophy, and leprosy. Nethrodaya's Public Interest Litigation (PIL) to consider the visually challenged persons on par with other differently abled led to a judgement from the Madras High Court on 19.09.2022, directing the Government of Tamil Nadu to consider extending the Monthly Pension Scheme for visually challenged persons, under the Differently Abled Category (WP No. 50052). Every order, every judgement has not only helped thousands from the visually challenged community and their families, but has also enabled other welfare institutions for the differently abled to work with dignity.

## Disability self-help unit exempted from Infrastructure and Amenities fee in Tamil Nadu

*CMDA told to approve building plan permit for construction*

CHENNAI: The Madras High Court has granted a self-help institution an exemption from paying Infrastructure & Amenities (I&A) charges and has asked the CMDA to approve the building plan permission for construction.

The petitioner, Nethrodaya, had sought to quash a letter from the CMDA that denied them an exemption from payment of Infrastructure & Amenities (I&A) charges. Nethrodaya is a self-help institution that works for the betterment of the differently-abled community.

They approached the High Court to seek approval for building plan permission for the second floor construction to the petitioner without having to pay infrastructure, amenities, regularisations fee and security deposit.

The CMDA in its letter had said that Nethrodaya would not be exempted from paying the charges as no institution has been exempted from paying the I&A charges. Further, the CMDA mentioned that if such a relaxation was given, it would set a precedent for others to claim.

The judge, M Sathyanarayanan, cited Section 113 of the Tamil Nadu Town and Country Planning Act, 1971 that specifies that the government may, subject to certain conditions, by notification, exempt any land or building or class of lands or building from all or any of the provisions of this Act or rules or regulations.

"In the light of the welfare acts being performed by the writ petitioner as pointed out, it is entitled to apply for the exemption of payment of the I&A charges under the above said provision," said Justice Sathyanarayanan.

The court said that the CMDA, being the statutory authority, shall also bear in mind the objects of the Disabilities Act, 2016. The government of TN shall also take into consideration this act and amend the Section 63 (8) of the Tamil Nadu Town and Country Planning Act, 1971 in respect of similar institutions.

"The plea is partly allowed and the impugned letter of the CMDA is set aside and the petitioner is at liberty to submit a representation seeking exemption for payment of I&A charges, within a period of two weeks from the date of receipt of the copy of this order to the Housing and Urban Development Department." The court provided the Housing and Urban Development Department 12 weeks to issue appropriate orders regarding the same.

In light of welfare acts

Justice Sathyanarayanan said "In the light of welfare acts being performed by the petitioner as pointed out, it is entitled to apply for the exemption of payment of I&A charges under the above said provision. As and when any representation is received in that regard from the petitioner, the Housing & Urban Development Dept shall positively consider it within a stipulated time."

## Visually impaired woman, who alleged she was denied posting, gets fresh appointment order

**K. Tharamani, who said she had earlier received an appointment order, but had not been allowed to join at her workplace, has now started work as a junior assistant at an office of the printing and stationery department in Salem**

Following repeated appeals **about being denied a posting** despite having an appointment order, K. Thamarai, a visually impaired woman who had cleared the Tamil Nadu Public Service Commission (TNPSC) Group IV exams, received a fresh appointment order and took up a posting as a junior assistant on Thursday.

"I am extremely happy that I have joined work. I was keen on becoming financially stable and helping my family. This is the first step towards that," said Ms Thamarai, who hails from Thiruvannamalai. While she had initially received a posting in Chennai, she has now taken up charge at an office of the printing and stationery department in Salem.

Ms Thamarai had cleared the Group IV exams with a score of 202.50 marks. The TNPSC and the Commissioner of the Printing department had issued appointment orders for her to join in the post of junior assistant. However, when she appeared at the printing department in Chennai in August to take up her posting, Ms Thamarai alleged that she had been told that since she was visually impaired, the job wasn't suitable for her. Furthermore, she alleged that the printing department had also issued a memo contrary to their own office proceedings issued for her appointment and that she wasn't able to join.

A complaint had been raised regarding this by C. Govindakrishnan, Founder, Nethrodaya with the the State Commissioner for Persons with Disabilities. The Commissioner, having the powers of a civil court, had from the Commissioner, Stationery and Printing Department and the Secretary, TNPSC based on the complaint given. In his complaint, Mr. Govindakrishnan had alleged non-implementation of the statutory rights granted under the Rights of Persons with Disabilities Act, 2016.

"We are extremely happy that Thamarai has received her joining orders and was able to begin working from today," Mr. Govindakrishnan said.

## Services Offered at Nethrodaya

Benefitting hundreds of visually challenged and differently-abled economically backward students hailing from remote villages of Tamil Nadu, Nethrodaya continues to impart best quality education, absolutely free of cost.

Nethrodaya practices inclusiveness with an integrated methodology. Here the visually challenged students and the orthopaedic students co-exist to learn and leverage upon each other's strengths, by overcoming their disability. Implemented successfully, this practice provides an opportunity for the orthopaedic students to read and write for the visually challenged and to share and exchange their books of knowledge.

### **Nethrodaya Free Residential Higher Secondary Special School for the Visually Challenged and Orthopaedic**

Recognized by the Government of Tamil Nadu, we have been imparting the best quality special education to the economically backward visually challenged as well as orthopedically disabled boys and girls from classes 1 to 12.

### **Nethrodaya College of Special Education**

Nethrodaya College of Special Education is approved by the Rehabilitation Council of India and affiliated to the Tamil Nadu Teachers' Education University (College Code 10229). It provides free admission to visually challenged and orthopedically disabled boys and girls from poor families, completely free-of-cost. With qualified faculties in special education, it ensures that young students with disabilities have the skills and ability to enter the workforce and gain meaningful employment, remain employed, and grow in their jobs.

### **Differently Abled Students Availing State of the Art Facility at Nethrodaya**

Nethrodaya's esteemed faculty comprises qualified special educators who have in-depth knowledge and hands-on experience in specialized teaching-learning methods. They value the empowerment of underprivileged differently abled students and strive to enable their active participation in the evolution of our society.

### **Computer Lab**

Nethrodaya's well-equipped computer lab equipped with the best quality screen readers, braille printers and free browsing facility for the visually challenged is the first of its kind in Tamil Nadu. It provides much needed training for the visually challenged to work with Microsoft Office, Internet, and emails on par with sighted persons. Thousands of students have passed out from Nethrodaya with enviable digital competence and settled in decent IT jobs with attractive salaries. They stand testimony to the success of Nethrodaya's computer training courses for the last twenty years.

### **Digital Audio and Braille Library**

Nethrodaya's Library is one of the best of its kind in India

with thousands of audio study materials for the visually challenged. Our library has a wide variety of books and study materials ranging from Tamil Nadu school and college textbooks to competitive exam study materials and motivational books. These books and materials have benefitted over thousands of differently-abled students in Tamil Nadu.

### **Reading Centre**

The warmth and liveliness of human reading can never be replaced by any machine. Realizing this truth, Nethrodaya appealed to hundreds of kind-hearted volunteers who continue to offer their eyesight and voice to read out books and study materials to the visually challenged students. These readers who read textbooks also lend voice for recording study materials and take the role of a scribe for the visually challenged to appear for their exams. They very often turn out to be excellent teachers and a window to the outer society for our students, thereby contributing to their holistic development.

Nethrodaya calls for retired people as volunteers too, who can lend their voice for reading and recording lessons for the visually challenged.

### **Fitness Centre**

Physical fitness is an inevitable ingredient for success, more so for the differently abled. Realizing this fact, Nethrodaya has established a fully functional high-tech fitness centre for our students where they can indulge in daily warmups, exercises, and bodybuilding. Specialized masters are invited to conduct yoga classes for our students on a routine basis so that they stay physically fit and mentally sound.

### **Auditorium**

Nethrodaya also has a well-equipped auditorium complete with tactile flooring and ramps for orthopaedic students which can accommodate 300 persons at a time, serving as a multi-functional hall to host seminars, workshops, conferences and marriages for the differently-abled providing quality service to the differently-abled population in Tamil Nadu.

### **Free Boarding Facilities**

Nethrodaya provides user-friendly, high-quality boarding and lodging facilities for its inmates, with nutritious, balanced food cooked by an in-house cook three times a day, clean drinking water, round-the-clock electricity with backup generators, and fire safety systems.

With separate dormitories for both boys and girls, the residential block is a barrier-free new building with a ramp facility. These facilities are provided completely free of cost and are being utilized by the underprivileged differently-abled students from remote villages of Tamil Nadu.

### **Music and Instruments**

Visually challenged are great musicians of all time in history. Nethrodaya appreciates students' talent and provides training in vocal and musical instruments to improve their employability in the music field and become self-reliant. We also conduct South Indian Level Singing Competition every year.

### Nethrodaya's Free Medical Helpline (+91-44-26533680)

Through its 24/7 Medical Help Line Nethrodaya provides timely and quality medical assistance to visually challenged and physically challenged persons who are suffering from various medical ailments, free of cost. Our helpline has come in very useful during need and over thousand visually challenged persons have benefitted from this service. Launched in 2004, the helpline is backed by a committed, hard-working team of volunteers and professionals, who pledge to serve those in need immediately.

"Amma, can you hear me?" could be a normal, day-to-day phrase in a conversation between any mother and child. But for us at Nethrodaya, it is a memorable moment filled with emotions, as our student, Komalnath, 17 years old boy with vision and hearing impairment, was able to hear his mother reply to his question for the first time! The medical team worked tirelessly to identify the right hearing aid for him and today, Komalnath can recognise the voices of all his loved ones. This gift of hearing has opened up a world of experience and possibilities for this hardworking young student of class 11, preparing for his board exams at Nethrodaya's Free Residential Special School.



### Death with Dignity

Nethrodaya launched a unique scheme "Death with Dignity" in all 38 districts of Tamil Nadu. We strongly believe that the death of visually challenged persons must be treated with utmost dignity, with decent cremation/burial. Due to lack of family support and poverty, most of them are unable to perform the last rites of their loved ones who are also visually challenged. With financial assistance through the scheme, they will now be able to perform the final rites and funeral of their deceased loved ones and give them a respectful farewell.

### Nethrodaya's self-employment schemes for the Visually Challenged Families

Initiated 20 Years ago, this scheme aims to provide a way of livelihood for the families of the visually challenged, by providing them with Seed Capital in the form of Marketable Products. These Products can be sold in the Suburban Train Network. This paves way for the visually challenged to make a sustainable monthly income and lead a dignified life. This noble scheme, with the objective of preventing the visually challenged from begging, has helped over 3000 visually impaired persons over the years.





## Assistance to Educate the Children of Visually Challenged Parents

The sighted children of visually challenged parents need good quality education to plan their future and take care of their parents in their old age. Nethrodaya devised a scheme to fund the education of children of visually challenged parents. This initiative is supported by Shree Saritha Jain Foundation. Thousands of such children, who are sighted, have benefited from this scheme, easing the burden of school fees on their visually challenged parents.

Nethrodaya wishes to dispel the myth that visually challenged couples give birth only to visually challenged children. On the contrary, the heartening fact is that visually challenged couples can give birth to healthy, sighted children.



Vasantha, a visually challenged lady lost her husband and was unable to educate her daughter due to poverty. She learnt about the scheme and applied for assistance. Nethrodaya paid for her daughter's fee in class 12 and encouraged her to pursue graduation against all obstacles. Her daughter, Indhuja, aims to become a Chartered Accountant and take care of her mother in her old age.

## Cow Project



While visual impairment creates many challenges for any person, blindness coupled with poverty, illiteracy, and rural background leaves the person devoid of any chances of survival.

Nethrodaya identifies such families in rural areas and provides them with a cow and a female calf. The cow is purchased under the supervision of cattle experts and experienced localities. As the cows are insured, families feel safe. Credible milk procurers are identified in the villages by Nethrodaya. Field visits are conducted periodically to ascertain the proper maintenance of cows. The cow is not only an asset now, it has also become the source of survival for hundreds of visually challenged families. Through this project, in the past

20 years, more than 400 Families have benefitted from all 38 districts of Tamil Nadu.

One such family is Krishnan, who is an illiterate and visually challenged, hailing from a remote village the in Dindigul district. He had no source of income. He has two kids and was unable to look after his family. Nethrodaya provided a cow and a female calf to his family. The new source of livelihood changed life for the family, who now feel secure with a stable income in their pockets.

## Monthly Free Grocery Distribution Scheme:

There are Visually Challenged families who are unable to feed their Children three times a day due to their poverty. In order to address this problem Nethrodaya provides free Groceries on monthly basis. This initiative has benefitted many such families. We thank D. Imman Educational Trust for their unconditional support.

Shankar, a visually challenged student was abandoned by his parents. Nethrodaya rescued him from Thiruvannamiyur, Chennai. He successfully completed his schooling at Nethrodaya Free Residential Higher Secondary Special School and is now pursuing his Bachelor Degree in Economics from a leading College in Chennai.



### Yogaraj

Yogaraj from Virudhunagar district of Tamil Nadu, lost his sight at the tender age of seven years. While in class six, he also developed hearing deficiency. But Yogaraj never allowed any of these deficiencies interfere with his studies. He approached Nethrodaya College of Special Education in 2019 seeking free admission in B.Ed course and completed it successfully in 2021. His dream of becoming a teacher and serving the underprivileged, needy in our society has become a reality now.
